FutureLV Draft General Land Use Plan Analysis

Several maps were displayed for the committee's review, including:

1. Natural Resources Plan – depicts high, medium, and low priorities on conservation as well as hydrography, riparian buffers, floodplains, wetlands, and hydric soils
2. Farmland Preservation Plan – depicts all county purchased easements
3. Park, Outdoor Recreation, Open Space and Scenic Plan – depicts recreation areas and walking trails (as exists and proposed by LVPC and municipalities)
4. Centers and Corridors Transportation Plan – identifies key transportation assets to identify where critical funding should go. Goals include making commuting easier, bringing jobs closer, make more opportunity for alternative forms of transportation.
5. General Land Use Plan
